我們相信 RBA 行為準則透過提高客戶和供應商的效率和生產力、改善工作條件、發展經濟以及致力提供當地社區更清潔的環境,可幫助所有參與供應鏈的人創造更好的社會、經濟和環境成果。力積電要求其供應商、承包商、服務提供商和分包商採用並遵守本準則。供應商對本準則的遵循程度將是力積電評估採購決策的考量之一。

PSMC also encourages suppliers to require their suppliers, contractors, services providers and subcontractors to adopt and comply with this Code. Suppliers' status of compliance with this Code will be one of the considerations for PSMC's evaluation of and decision making on the purchasing.
